Justification:

Modification is sought due to:

- Decrease in physical target of CW1 from 424.00 lineal meters to 410.52 lineal meters and increase in unit cost per lineal meter of CW1 due to the design of the project utilizing Reinforced Concrete Slope Protection in Steel Sheet Pile foundation (L= 6.0m). The design of the project has an average height of 6.0 meters (2 berms) and width of 18.0 meters.
- Attached are the following supporting documents: Approved Program of Works (POW), Detailed Engineering Design (DED), Certificate of Availability of Funds, Geotagged Photos, GIS Map, Certification on the Reasonableness of Cost dated March 17, 2023.
