 Decrease in physical tagget/increase in unit cost of CW1- Rehabilitation/Major Repair of Flood Control Structure due to the following:

The rehabilitation of flood control structure has a design requirement of concrete revetment on 9 meters steel sheet pile with single berm structure. Due to the existing single berm structure in the area, it was necessary to extend the flood control structure with the same design requirement. In consideration of the washed-out portion in the project location, the height of the proposed revetment was designed to be approximately 5.61 m high.

Addition of some miscellaneous structures, specifically the railings, which represents 1.865% of the total scope of work as reflected in the Certificate of Reasonableness of Cost Estimate.

o The Derivation of Unit Cost based on the length acquired from the Detailed Engineering Design Plans in conformance with the design criteria/requirements. Items relevant to Rehabilitation of Flood Control Structure are incorporated in derivation of unit cost.

Attached are the following documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds, BP Form 202, Certificate of Reasonableness of Cost Estimates, Certificate of "No Overlapping" and "Not within Warranty Period", Geotagged photographs, Approved Programs of Work (POW) with Detailed Unit Price Analysis (DUPA), and Approved Detailed Engineering Plans (PED), Project Impact Analysis, and Multi-Hazard Map.
