Justification: The project has to be n	nodified in view of t	he following:	loca	l'ion.	

- Decrease in physical target/ increase in unit cost of CW1- Construction of Concrete Road, to pave the existing gravel road, to provide better and safer road access for resident thereat. The proposed Concrete Road will ease the road traffic and will lessen travel time.
- CW2- Road widening was introduced at the end of the proposed two-lane PCCP to improve the narrow and rugged road going towards the far-flung Sitio of Katao, Buringal. The road widening includes earthworks such as clearing and grubbing, removal of structures and obstruction, surplus excavation (common and rock), embankment, etc. consisting of 27.90% of the total direct cost.
- The road traverses on a mountainous terrain with portion of rolling terrain as per actual site condition instead of the anticipated flat terrain. Thus, CW3- Construction of Road Slope Protection Structure was introduced to provide safety to motoristss traversing the road section. The Construction of Road Slope Protection includes drainages and road slope protection structure such as Grouted Riprap and Stone Mansory to protect the road from soil erosion, landside, and roadslips.
