Justification:

- The increase in physical target/decrease in unit cost of CW1-Construction of Concrete Roads due to the decrease of road width from 6.1 meters to 5 meters to be consistent and to adopt the existing road width.
- There is no existing pavement along the stretch of the project area hence the change in type of work from Rehabilitation of Concrete Road to Construction of Concrete Road.
- The derived unit cost is based on validated/ approved Detailed Unit Price Analysis (DUPA) and Program of Work (POW).
