7 Due to the increase in some material prices updated in the First Quarter of the Construction Materials Prices Data (CMPD) 2023, the total construction cost increased, hence the decrease in the physical target from 389,00 ln.m. to 384,00 ln.m.

- Also, the increase in the unit cost for CW1 was due to the project's earthwork activities that require an additional volume of boulder fill to stabilize the slopes and prevent erosion of the neighboring residential structures.
